President's Message — Dr. Frank Bruno

When I entered the field of Education in 1971, it was a "kinder and gentler" day and age. School children laughed and played, traveled to school without concerns, respected their parents and teachers and followed directions unauestioninaly. They were the squeaky-clean Leave It to Beaver, Wonder Bread generation. A loaf of bread cost \$0.25, Gasoline was \$0.36 per gallon, and the average price of a new U.S. built car was \$3,642. Were there bullies? Sure. There were always bullies, but kids learned how to deal with them. Columbine and mass shootings in K-12 schools were still 28 years away. One topic I never dreamed I would be discussing was Suicide. Now, my Commonwealth of Pennsylvania, has found it necessary to mandate by law, the formulation and adoption of school district policy which requires

Anti-Suicide education for all students and staff members. It requires the creation in each school of the position of Building Level Suicide Prevention Coordinator. It requires the appointment of a District Level Suicide Prevention Coordinator. It mandates 4 hours of Suicide Prevention training for all staff, every five years. It requires the collection of data on suicide threats, ideation and attempts. It requires protocols be put in place for assessing, responding, recording and reporting of such. In the first year of implementation, I was amazed at the number of incidents. especially in the elementary grade levels. This legislation was brought about by a demonstrated need. In 2013, 1,636 youth in the U.S. age 10-18 died by suicide. In PA, that number was 72. Across the U.S., suicide

is the 2nd leading cause of death in this age group! More than one in every 10 high school students reported having attempted suicide. Nearly 1 in 6 students between the ages of 12-17 have seriously considered it. More than 30% of LGBTQ youth report at least one suicide attempt within the last year. More than 50% of Transgender youth will have had at least one suicide attempt by their 20th birthday. Stop! Look at what has just been referenced, Bullying, Mass School Shootings, Suicide, LGBTQ and Transgender youth. The Pupil Services Administrator of today is faced with complex issues which were never even considered in educational programs of the past. It is no longer enough to offer Guidance Counseling, Nursing Services, Special Education instruction and Truancy intervention. . The complications of
